1. Promotion name

2. Promoter

3. Promotion period

From 12:00am (AEST) on 27 April 2026 to 11:59pm (AEST) on 3 July 2026 (Promotion Period).

4. Eligibility

This promotion is open only to eligible Lincoln Sentry Australian trade account holders.

The following are not eligible to participate:

- employees, contractors, agents or officers of the Promoter and their immediate families;
- customers with suspended or closed accounts; or
- customers who are in breach of the Promoter's trading terms or who have overdue monies owing at the time the gift voucher is issued.

The Promoter may, at any time, require verification of eligibility and reserves the right to disqualify any participant who provides incomplete, misleading or fraudulent information.

5. Qualifying purchase

Purchases:

- must be completed and invoiced during the Promotion Period;
- cannot be aggregated across multiple transactions;
